2. If the Bidder withdraws its Bid during the period of bid validity as specified in this RFP and as extended by the BSSS from time to time;
3. If the bidder attempts to influence the BSSS, on the BSSS's decision on scrutiny, comparison & evaluation of tenders and awarding the contract;
4. In the case of Selected Bidder, if it fails within the specified time limit:
 - a. to sign the contract and/or;
 - b. to furnish the Performance Security(PS) within the period prescribed in the Letter of Acceptance (LoA)

We undertake to pay the tender Inviting Authority up to the above amount upon receipts of its first written demand, without the Tender Inviting Authority having to substantiate its demand, provided that in its demand the Tender Inviting Authority will note that the amount claimed by it is due to it owing to the occurrence of one or both the two conditions, specifying the occurred condition(s).
