



**CORRIGENDUM to Minutes of the Meeting of Technical Committee published on eproc portal – regarding Technical Bid Evaluation for ‘Beneficiary Identification System’**

1. With reference to the Notice Inviting Tender (NIT) Reference No.: - 03/ BSSS/ Beneficiary Identification System/ 2020-21 for selection of Agency to Operate Beneficiary Identification System for Bihar Swasthya Suraksha Samiti (BSSS), the minutes of meeting of technical committee (held on Nov 12, 2020) concerning technical evaluation of received bids, alongwith Technical Bid Comparison Sheet were published on the eproc portal and *biswass.bihar.gov.in*, and also shared to all the bidders through email.
2. Upon due review of the published documents, a discrepancy has been identified for details captured for ‘Medsave Health Insurance TPA Ltd.’ in the published ‘Minutes of Meeting of the Technical Committee’ due to human error. The ITR for AY 2019-20 was received, as mentioned in the Technical Bid Comparison Sheet, but was mentioned as ‘not submitted’ in ‘Minutes of Meeting’ due to human error.
3. Based on re-review of the bids received for ‘Medsave Health Insurance TPA Ltd.’, the error identified in Minutes of Meeting has been identified and rectified as follows:
