



Minutes of the Meeting of Technical Committee held on 12.11.2020 at 11 AM. of the Tender published for selection of Implementation Support Agency (ISA) for the implementation of Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana in the State of Bihar

1. With reference to the Notice Inviting Tender (NIT) Reference No.: - 02/ BSSS/ Implementation Support Agency/ 2020-21 for selection of Implementation Support Agency (ISA) for the implementation of Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana in the State of Bihar, published in leading newspapers [PR.No. 005491 (Ni Ni) 2020-21 Dated 27-08-2020] and uploaded on the website "<http://www.eproc.bihar.gov.in/BELTRON>" and "[biswss.bihar.gov.in](http://www.biswss.bihar.gov.in)", meeting of Technical Committee of received technical bids was held on 12/11/2020 at 11 AM. in the Conference Hall of the 'Bihar Swasthya Suraksha Samiti (BSSS)' for evaluation of technical bids.

3. Technical bids received from following 8 bidders were evaluated:-


- Vidal Health Insurance TPA Pvt. Ltd.
- Paramount Health Services & Insurance TPA Pvt. Ltd.
- MD India Health Insurance TPA Pvt. Ltd.
- Good Health Insurance TPA Ltd.
- Health India Insurance TPA Services Pvt. Ltd.
- Medsave Health Insurance TPA Ltd.
- Medi Assist Insurance TPA Pvt. Ltd.
- Family Health Plan Insurance TPA Ltd.




4. Technical committee undertook the technical bid evaluation based on the received technical bid documents. Technical Bid Comparative Chart is annexed as "Annexure-A".
5. Shortfall of documents were identified for Bidder 2 (Paramount Health Services & Insurance TPA Pvt. Ltd.) and Bidder 5 (Health India Insurance TPA Services Pvt. Ltd.) i.e. these bidders did not submit the required documents proving 'Experience of handling at least 50,000 health claims (Annual Average) during FY 2017-18, FY 2018-19 & FY 2019-20' – for FY 2019-20.

6. However, even if considered 'zero' health claims processed during FY 2019-20, in the absence of receipt of required document regarding 'Experience of handling at least 50,000 health claims (Annual Average)' for FY 2019-20, their annual average for the last 3 years is higher than the required 50,000 (annual average) health claims. Therefore, the committee has decided to consider their bids.

Recommendation: Technical committee has evaluated the received bids and has found all 8 (eight) bidders to be technically eligible, based on the eligibility criteria defined in the tender documents, and recommends that the financial bids of all 8 (eight) bidders may be opened for evaluation.
